In partnership with the Graduate Management Admission Council (GMAC), the test administrators of the Graduate Management Admission Test (GMAT), Michigan Ross Specialized Master's Programs has been provided with a very limited number of GMAT Fee Waivers. GMAT Fee Waivers help economically disadvantaged test takers have access to the exam, even if they cannot afford the fees.

Consideration for economically disadvantaged test takers will include, but not be limited to those from historically underrepresented groups including first-generation college students, students from income-restricted households, and students from certain geographical regions.

Recipients will be awarded a one-time application fee waiver to be applied when scheduling a future test administration; it is not a reimbursement. Students must register and sit for the GMAT by June 4, 2019. Waivers are limited and will be awarded on a first-come, first-serve basis.
